

ADMISSION REQUIREMENTS 2021

FIRST-YEAR ADMISSION – Global Business and Business Management tracks

◆ ONLINE APPLICATION

The minimum requirements in order to apply to EDHEC undergraduate programme are to have a good academic record and to graduate from an international school preparing the equivalent of the French baccalaureate (IB, High school diploma, A/AS-Level, Abitur, Diploma di maturità, Gaokao...). A limited number of students may enroll for the Global Business track and Business Management track 100% in English.

There is not a minimum score required for the International Baccalaureate. Admission is only possible if you provide the mandatory visa and requirements asked by the French authorities before the start of the school year. You can choose to apply for the first or second admission session.

5 STEPS

1. Install the **emage-me** from Apple or Google stores.
2. Create your account using the same email address as for your online application, and select the campuses for which you want to apply.
3. Respond to scenarios and questions to better identify and value your personality traits and well-being. You get real time your **emage-me** profile, which is confidential and not shared with schools at this stage.
4. Share your **emage-me** profile with relatives to gather their vision of your strengths and axes of development. You can select the received feedbacks that you want to share with the school.
5. Upon payment of your examination registration, your **emage-me** profile is shared with the school and you are invited to answer questions about your motivations and values, in preparation for the oral presentation.

Global Business and Business Management-English tracks require a minimum score of the IELTS, TOEFL or CAMBRIDGE tests.

MANDATORY DOCUMENTS:

- **Copy of Education Certificate or School Enrolment Certificate or Proof of Attendance**
- **Official language score** or proof of exam registration or proof of exemption
- **Transcript of records** of your previous year (grade 11) and semester 1/Term 1 of final year (grade 12). If you don't have your semester 1 transcript by January 19, 2021, please upload your interim report.

As a priority, please indicate grades corresponding to:

- Science, Mathematics, Economics or/and Social Sciences courses
- Language courses: First Language and second language

If you are not able to obtain your transcript for the first trimester of the final year, please upload a certificate of your predicted grades.

You will have to pay your tuition fees via wire transfer. Direct debit is not possible.
